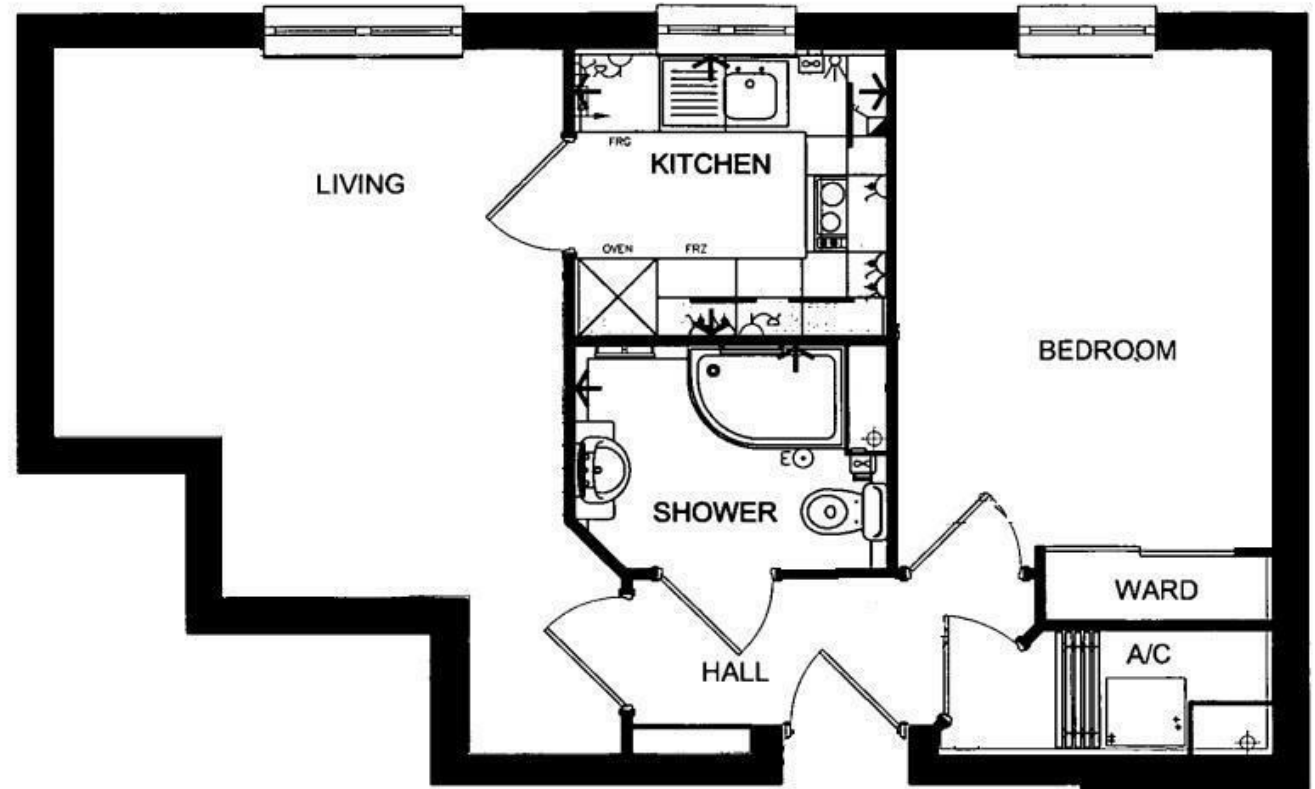
## Security Deposit
