The Living Room offers a feature electric fireplace with attractive surround. There is plenty of space for living and dining room furniture and a french door opens to the owners private patio area.

The Kitchen is accessed via the Living Room with a range of modern eye and base level units with working surfaces over and tiled splashbacks. There is a built-in waist-height oven, 4-ring electric hob with extractor hood over, slimline dishwasher, washer/dryer, a fridge and frost-free freezer. A window allows for light and ventilation.

Bedroom One is a good-sized double room with a walkin wardrobe. A large window provides lots of natural light and garden views. An ensuite offers a curved shower cubicle with handrail, a heated towel rail, WC and wash hand basin with vanity unit below.
