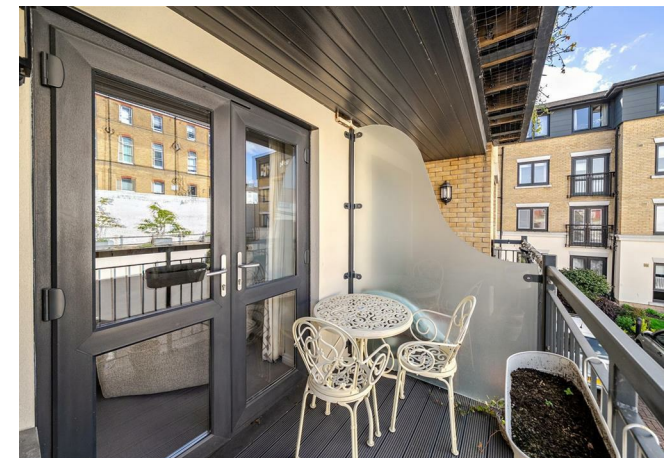
The Lounge offers ample space for living and features electric fireplace with attractive surround. There is a door leading to the Balcony and another door to the Kitchen.

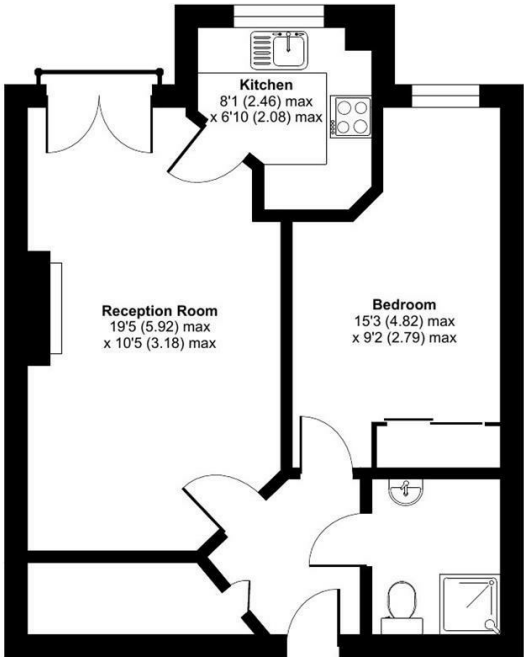
