Conveniently located within this Medieval and Historic Market town of Huntingdon. Moorhouse Lodge, a stylish new retirement development, situated on the corner of Edison Bell Way and Ermine Street and comprises of 47 one and two bedroom independent living apartments.

Moorhouse Lodge is named after the first airman to be awarded the Victoria Cross (VC); William RhodesMoorhouse. William was educated at Trinity College, Cambridge and with his friend James Radley, they formed Portholme Aerodrome in 1911 and developed their own monoplane. In August 1914, William joined the Royal Flying Corps and during a raid over Courtai in 1915, he was fatally injured and later died from his wounds. His actions earned him Britain's highest honour for gallantry; the first Victoria Cross to be won in the air. Close to the Lodge are a number of amenities including the Charles Hicks Medical Centre, a pharmacy and two supermarkets. Within Huntingdon town are a range of leading high street stores and a great range of independent stores, boutiques, cafés, restaurants, banks, historic public houses and medical centres. Huntingdon has an Indoor and Outdoor Bowls Club, Brampton Golf Course and Cambridge Golf is approximately 6 miles away.

Road, rail and air links to, from and around Huntingdon couldn't be easier. From Huntingdon train station you can get a regular service to the east coast, London and the north of England. Easy access by road using the A14 and A1. The nearest major airport for international and domestic flights is from London Stansted.

The Lodge manager is on hand throughout the day to support the owners and keep the development in perfect shape. They arrange many regular events in the Owners' Lounge from coffee mornings to games afternoons.


