Bedroom Two is another ample sized double bedroom that could also be used as a separate Study, Dining Room or Hobby Room.

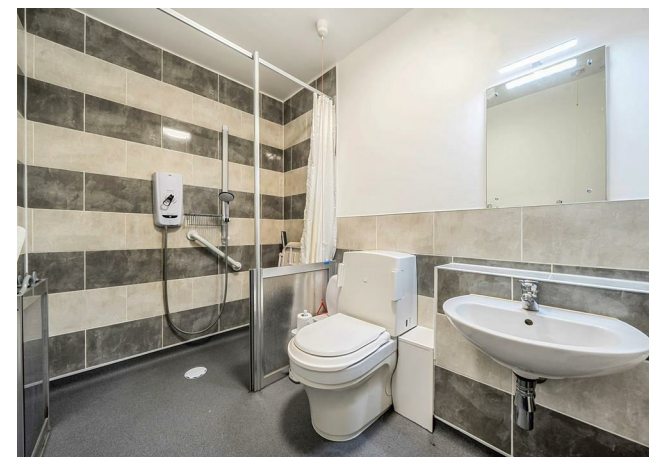
The shower room offers a large walk-in shower with handrail and shower seat, a WC and wash basin.

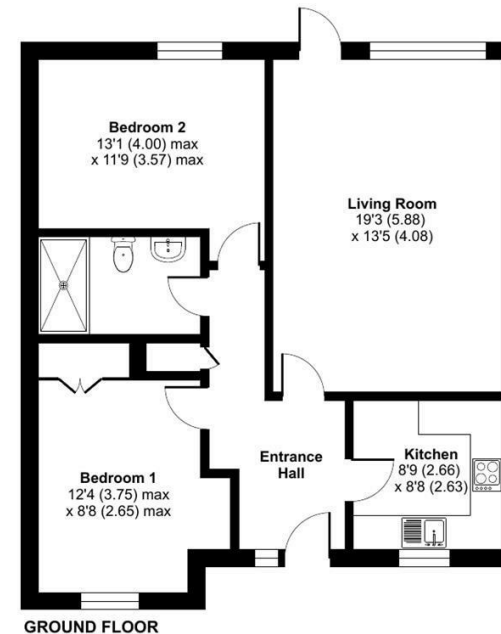
